## Out of Area fees

The term resident means, with regard to right of burial and interment fees:

- a person who lives in the High Peak; or
- a person who actually dies within the Borough's boundaries.

The right of burial in a grave may be purchased by a High Peak resident (at standard residents fees) for the burial of a non-resident. However, the interment fees for the non-resident will be charged at non-resident rates.

The right of burial in a grave may be purchased by a non-resident at standard residents' fees for the imminent burial of a High Peak resident (i.e. does not apply to pre-purchased graves). The interment fees will be charged at resident rates.

The term "resident" means, for interments at resident's charges:

- residents as above;
- a person who, although living outside the borough when they died, used to be a resident in the Borough at the time when they or their direct next of kin bought the exclusive right of burial (next of kin = wife, husband, mother, father, brother, sister, son and daughter only);
- residents of the borough who moved directly from the High Peak into a nursing home, hospital or other care environment outside the borough before they died;
- a person who had moved out of the borough within the previous 2 years and was formerly a long-term resident in the borough (for a minimum of 10 years).

The Cemetery Officer will require proof of residency in such cases before the burial takes place. No right of appeal exists after the burial has taken place.
