
- Attracting around 90,000 virtual visits to Buxton Museum and Art Gallery

Since 2016-17 the Secretary of State has made an offer to councils with a responsibility for adult social care to charge an additional 'precept' on its council tax without holding a referendum, to assist authorities in meeting expenditure on adult social care.

Eligible households in council tax bands A-D will receive a one-off council tax rebate of £150 from April that is non-repayable, administered by district/borough councils.

For 2022-23 the council will levy the Government's adult social care precept of 1% (the max is 3%) towards the cost of older & vulnerable people's services. More at derbyshire.gov.uk/budget
